**Eligibility:** Open to all USATT members. Regular USATT memberships or associate memberships/tournament passes are available on this entry form.

**Format:** **Singles:** Double-Round Robin. **1<sup>st</sup> Round:** Players will be grouped using "snake" system in accordance with USATT Tournament Guide. **2<sup>nd</sup> Round: All players will advance to A, B, C, D or E Divisions, depending upon the win/loss records and number of players.** Ties will be broken in accordance with the USATT Tournament Guide. All matches will be 3 out of 5 games.  
All players play morning and afternoon round robins.  
**Doubles**(Unsanctioned) – Combined ratings must be under 3600. Eligibility based on USATT ratings as of January 1, 2019. Format will be based on number of entries. Must have USATT rating or best guess estimated rating.

**Deadline:** Entries must be received by **January 24<sup>th</sup>, 2019** with fees or have made special arrangements with Mark Richterman.

**Refunds:** Cancellations prior to **January 24<sup>th</sup>, 2019** will be refunded.  
"No Shows" without notification will not be refunded. Late medical cancellation refunds are at the tournament directors' discretion and will be conditional upon finding a replacement player.
